

GENERAL TERMS OF PARTICIPATION IN BOCCONI ALUMNI COMMUNITY EVENTS

Art.1 Subject of Contract

1.1 These General Terms regulate the participation, subject to a fee, by persons who are interested, in events (Events/Event) organized by the Luigi Bocconi Commercial University, based in Milan, Via Sarfatti 25 (Bocconi University), thru its Alumni Community (Bocconi Alumni Community) establishing the terms, methods and conditions of participation.

1.2 The characteristics of each individual Event are indicated in the registration/participation form (Registration Form) available online at the website www.bocconialumni.it (the Website).

1.3 The person participating in the Event (Participant) expressly accepts and undertakes to respect these General Terms of Participation and acknowledges that these Terms may be changed and/or updated at any time by Bocconi University, which will inform third parties of such changes/updates via the normal communication channels found at the website www.bocconialumni.it.

Art.2 Pre-Contractual Information

2.1 The Participant declares to have read, prior to paying the fee indicated in Articles 3 and 4 below, to understand and to accept all information and provisions contained in the Registration Form and in these General Terms of Participation, both documents found at the Website, illustrating the main characteristics of the Event, the geographical address and identity of Bocconi University, contact details, fee and payment methods.

Art.3 Fee and Payment Methods

3.1 The fee for participating in the Event (Fee) is indicated in the respective Registration Form.

3.2 The Fee, understood to be made in the name and on behalf of the invoice holders, must be paid upon registering for the Event, by following the procedure indicated in Article 4 below, choosing from one of the following methods, which will be indicated each time for each specific Event:

Non-transferable BANKER'S CHECK or cashier's check, in the name of Bocconi University

BANK TRANSFER

CREDIT CARD (Visa Eurocard/Mastercard American Express)

PAYPAL

MYBANK

Payment via the platform which is accessed by clicking “Register Now” in the Registration Form.

4. Conclusion of Contract

4.1 The Contract between the Participant and Bocconi University is concluded exclusively via the internet by the Participant accessing the website www.bocconialumni.it. By following the procedures indicated therein, the Participant will then express his/her consent to registration and participation in the Event.

4.2 The Contract concerning participation in the Event is concluded by way of consent to participation in the Event manifested by the Participant by completing the following phases:

(i) choosing the Event available on the website by point and click method

(ii) reading and fully completing the Registration Form for the Event and submitting the same, by point and click method

(iii) choosing the payment method of the participation fee for the Event

(iv) reading these General Terms of Participation and accepting them with simultaneous payment by point and click method

(v) paying the Fee as indicated in Article 3 above.

4.2 The Participant may only participate in the Event upon receiving confirmation of receipt of payment of the Fee and only then will his/her registration be considered effective and final.

4.3 Having shown consent to the finalization of the procedure indicated above, the Participant will receive an e-mail from Bocconi University confirming the registration and payment, with the invoice attached.

Art.5 Data Security and Confidentiality

5.1 The Participant guarantees that he/she legitimately has use of all information entered onto the Website for the purposes of purchasing the participation in the Event, also ensuring

that the same do not violate in any way, directly or indirectly, rights of third parties. Therefore, the Participant undertakes not to enter data for which he/she does not have full rights of use.

5.2 It is also prohibited for the Participant to enter false and/or invented data in the registration process for the Event and in subsequent communications linked to the aforementioned registration. For that purpose, the Participant indemnifies Bocconi University:

- from any liability deriving from the entry of incorrect data and tax documents, as the Participant is solely liable for the correct data entry;
- from any obligation and/or burden of assessment and control, direct and indirect, in that regard.
- from any unlawful or unauthorized payment of the Fee

5.3 If the falsity of the data provided is ascertained, by Bocconi University or subject to a report by third parties, Bocconi University reserves the right to prevent/suspend the Participant's registration and the respective participation in the Event.

Art.6 Participant's responsibilities and obligations

6.1 If the Participant behaves in a manner contrary to good faith, and in the event of any violation of the obligations indicated in these General Terms of Participation, Bocconi University reserves the right to prevent the Participant from participating in the Event and, if necessary, to take appropriate actions to protect its rights, therein including compensation for any damages suffered.

6.2 Bocconi University will not in any case be deemed liable for:

- any prejudice/damage suffered by the Participant attributable to participation at the Event
- any fact that prevents the Participant from participating in the Event having finalized the registration in accordance with Article 4 above
- the cancellation of the Event for any reason, without prejudice to the provisions laid down in Article 7.4 below.
- any change relating to the contents and logistical characteristics of the Event

6.3. Bocconi University, in addition, may not be held liable for non-fulfillments of its obligations, relating to the Event, deriving from causes not reasonably foreseeable, from impediments beyond the sphere of its direct and immediate control, or from causes of force majeure.

Art.7 Terms of Withdrawal

7.1 The Participant is permitted to withdraw, having finalized the registration in accordance with Article 4 above, up to the last day permitted for registering for the Event as indicated in the respective Registration Form available at the Website, by sending the communication of withdrawal to the e-mail address eventi@bocconialumni.it; in that case, the Participant will be refunded the full Fee.

7.2 If the Participant manifests the intention not to participate in the Event but gives written cancellation beyond the terms indicated in Art. 7.1, he/she will not be entitled to any refund.

7.3 Any failure to participate in the Event for any reason, even not resulting from the will or actions of the Participant, does not attribute to the latter any right to a refund, even partial, of the Fee.

7.4 If the Event is cancelled for any reason, the Participant will be entitled to the refund of the Fee.

Art.8 Privacy Policy and Consent to Personal Data Processing in accordance with the GDPR

8.1. Personal data is processed by Bocconi University in full respect of the provisions of EU Regulation 2016/679.

8.2 The Participant declares to have read and to accept Bocconi University's Information and Privacy Policy found at the Website.

Art.9 Court with jurisdiction

9.1 Any dispute deriving from the Contract or related thereto will be dealt with exclusively:

- a) by the Court in the location of residence or domicile of the Participant
- b) exclusively by the Court of Milan, in every other case.
